### **DESCRIPTION**

The property for sale is a Tenement House in the heart of Torun Old Town. The property consists of the main building and annex. There are 6 offices and 10 flats in the property. The current monthly income of the property in the current rental structure is PLN 8.000.

The property has 1 land register in the Court in Torun KW NO TO1T/00001502/6 (not separate land register for each of the flats).

The property has gothic elements on the front elevation, staircase and in some offices. All necessary conservation and renovation works have been done regularly on the building.

## **LOCATION**

The property is located at Piekary 11 Street, 350 metres from the main Old Market in Torun,

The neighbouring properties are the Lithuanian embassy, lawyers' offices, the notaries and swear translator's office.

#### **MEDIA**

The property is connected with all services: electricity, gas, sewage and water. All flats and offices have individual bathrooms and toilets. All offices have gas heating with new ovens. 3 flats have gas heating, 2 flats have electric heating and the remaining flats have coal ovens.

There are coal ovens in 5 flats and electric heating in 2 flats.


