More recently it was a home for street artist and screen printer Banksy. Located a short walk from Old Street station (Northern line) and Shoreditch High Street station (London overground), and with both Moorgate and Liverpool Street stations under a 10 minute walk away (providing further access to Northern, Circle, Metropolitan and Hammersmith & City lines, as well as National Rail services).

This warehouse office situated on the third floor of this converted Victorian warehouse building and has an abundance of character including original sash windows, timbers floors, exposed brickwork and excellent floor to ceiling heights. The floor benefits from an open plan layout with kitchenette in situ.
