This lovely three bedroom home is offered in excellent presentation and, being built only eight years ago benefits from modern fittings and is still under warranty, meaning peace of mind and low maintenance living. A very appealing energy rating B suggests you should expect very good efficiency and heating economy. The house is available to purchase 60% (or more) on the shared ownership scheme. The property is also available to purchase 100%.

The accommodation briefly comprises: entrance hall, w/c, fitted kitchen, living/dining room, three good size bedrooms and a family bathroom. There is a front garden and driveway and gated access to the rear garden which is mainly lawn with a storage shed and a paved patio.

Location

The house is located in a peaceful setting close to the centre of the village and just a stone's throw from play parks and countryside walks. Just a short stroll away, is The Oak; a traditional thatched family pub/restaurant, and within easy walking distance you will find the village store and post office, The Bell Inn, primary school, church, cricket club, Aston Park (excellent for dog walks) with play area, café, five a side football pitch and allotments. There is a petrol station, doctors surgery, dentist and pharmacy. There are several excellent golf courses a short drive away including Chiltern Forest a little over a mile away. There is a regular bus service through the village linking Aylesbury to Watford and the A41 dual carriageway is easily accessible giving convenient access to the M25 (jtn 20) in 15 mins or so making the journey to Heathrow and other London airports quite simple. There are train stations at Tring (serving London Euston) and nearby Wendover and Aylesbury (Marylebone). The property also falls within the catchment area for the highly sought after Grammar Schools in Aylesbury.

This property is currently under shared ownership in conjunction with Bromford Housing Association who have criteria for any purchase, the advertised price is for the sellers 60% share. £467.72 per month is paid to the Housing Association as rent for the retained share. Service Charge is £47.60. Please contact with Bromford Housing Association for guidance on purchase requirements. In addition, Bromford Housing Association have advised that they would be prepared to staircase a transaction to 100% Freehold ownership. This would mean that any potential purchaser would buy the vendor's 60% share and the remaining 40% share from Bromford Housing Association providing a Freehold purchase on completion. 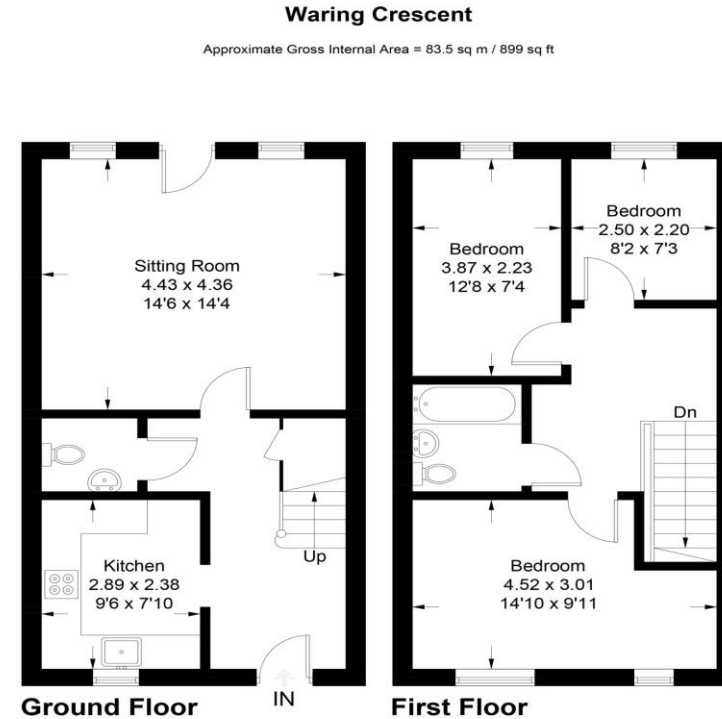
