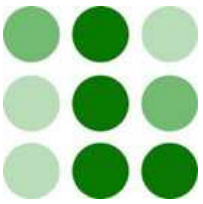

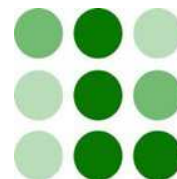

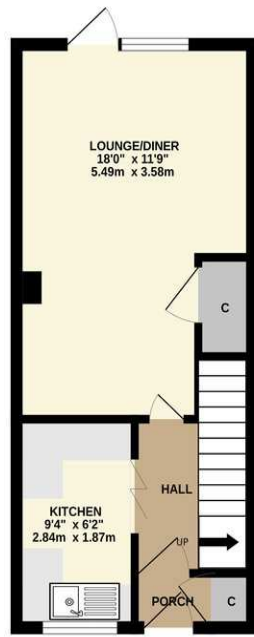
Garage is a short walk away located in a block.

To the front there is a lawn area with shrubs in situ, concrete path leads to the front door.

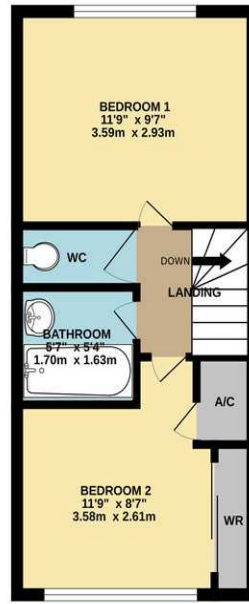

GROUND FLOOR



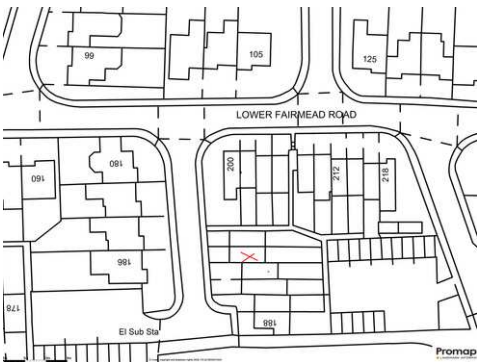
1ST FLOOR
