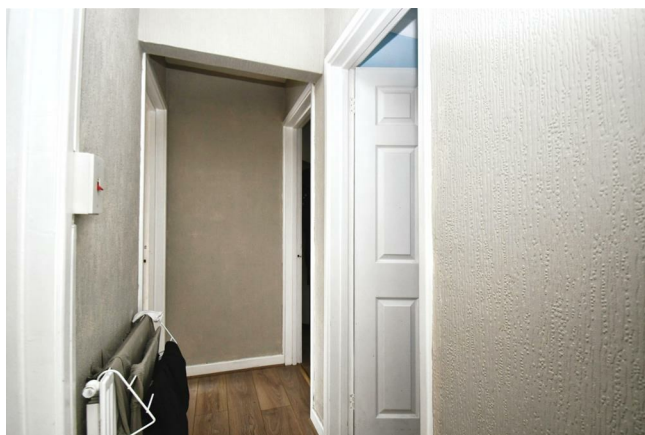

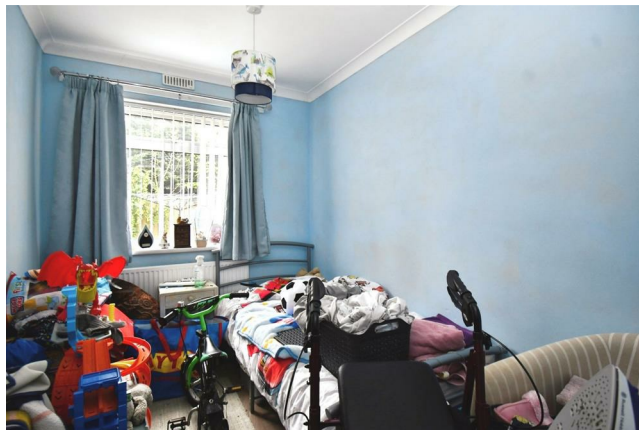

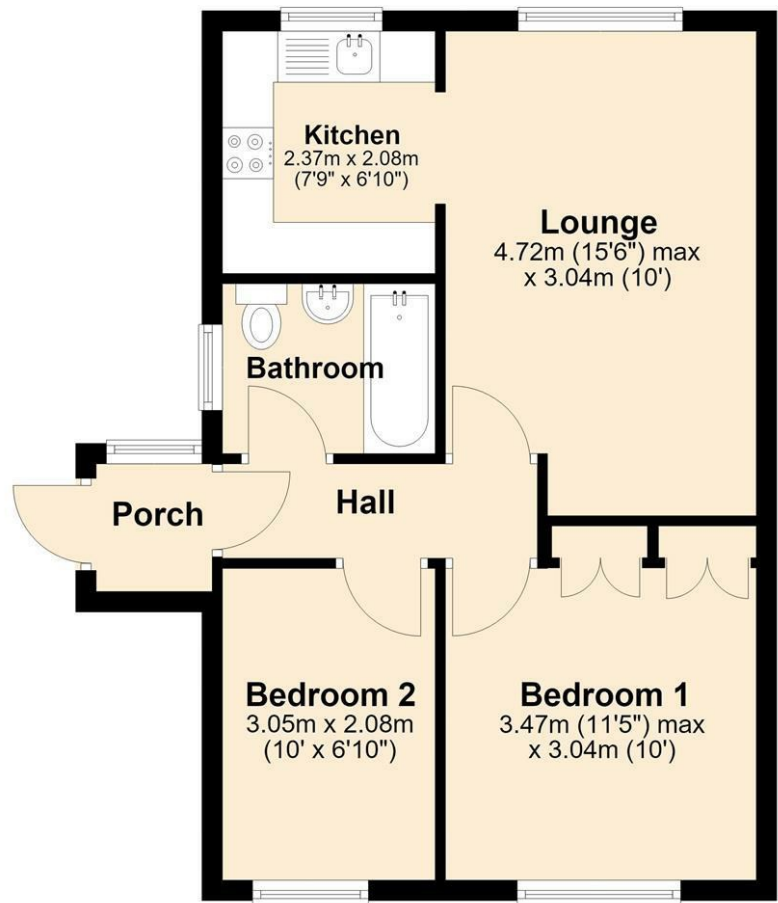

Floor Plan

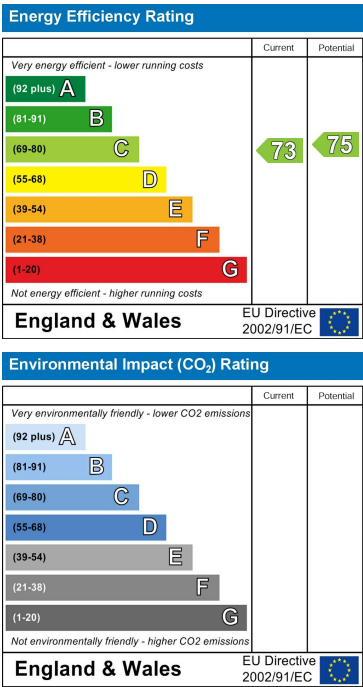
Ground Floor
