Entrance Hall

Double-glazed door to the front and stairs to the first floor. Doors to the cloakroom and the kitchen. Opens into the lounge.

Cloakroom

Wash hand basin and low-level WC. Radiator and double-glazed obscured window to the side.

Kitchen

Fitted with a mix of wall and base units with work top over, sink with drainer, eye-level electric oven and microwave plus a gas hob with extractor fan over. Integrated dishwasher. Space for a fridge/freezer. Space for a dining table and chairs, LVT flooring, vertical radiator and double-glazed window to the front.

Lounge

TV point, vertical radiator, LVT flooring and double-glazed window to the rear. Double-glazed doors leading out to the garden.

First Floor Landing

Stairs from the ground floor, storage cupboard and carpet. Doors to all bedrooms and the family bathroom.

Bedroom One

Built-in wardrobes with hanging space and storage, carpet, radiator and double-glazed window to the front.

Bedroom Two

Built-in wardrobes with hanging space and storage, carpet, radiator and double-glazed window to the rear.

Bedroom Three

Radiator, carpet and double-glazed window to the rear.

Bathroom

Fully tiled with a pedestal wash hand basin with mixer tap, low-level WC and a bath with a shower screen and shower over. Heated towel rail and double-glazed obscured window.

Outside Front Garden

Storage cupboard and a path leading to the front door.

Rear Garden

Enclosed by a brick wall and fencing the garden is mainly laid with gravel and a small patio area. Driveway leading to the garage.

Garage

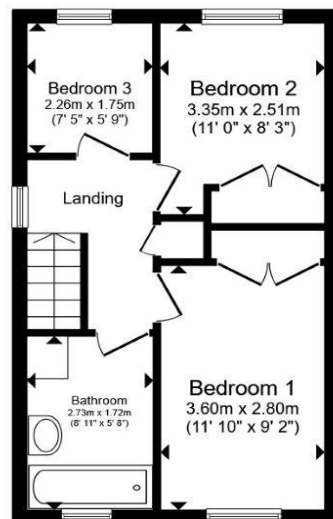
Garage with up & over door, central heating boiler and power.
