Entrance Hall

Entered via door to the side aspect, door to storage cupboard, radiator and doors leading to all rooms.

Lounge/ Dining Room

Double glazed door to the rear aspect leading to rear garden, feature fireplace with stone surround, two radiators and door leading to kitchen.

Kitchen

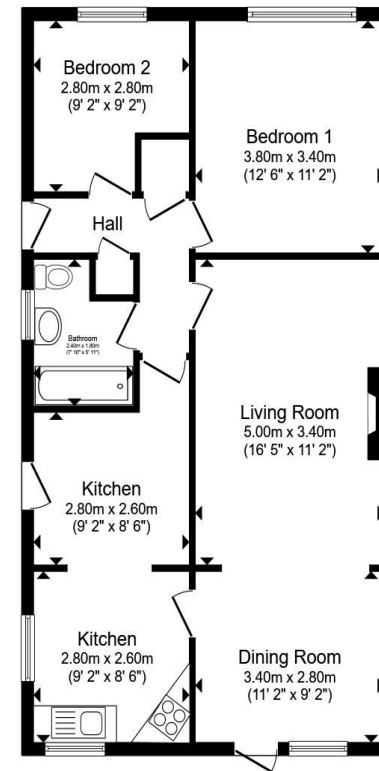
