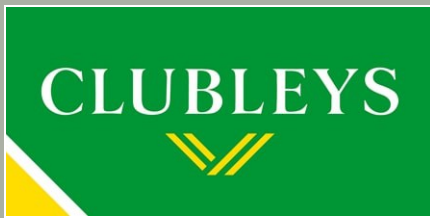
A particularly appealing feature is the apartment's own private rear entrance door, which opens onto a small paved area, providing a pleasant spot for a bench and potted plants.

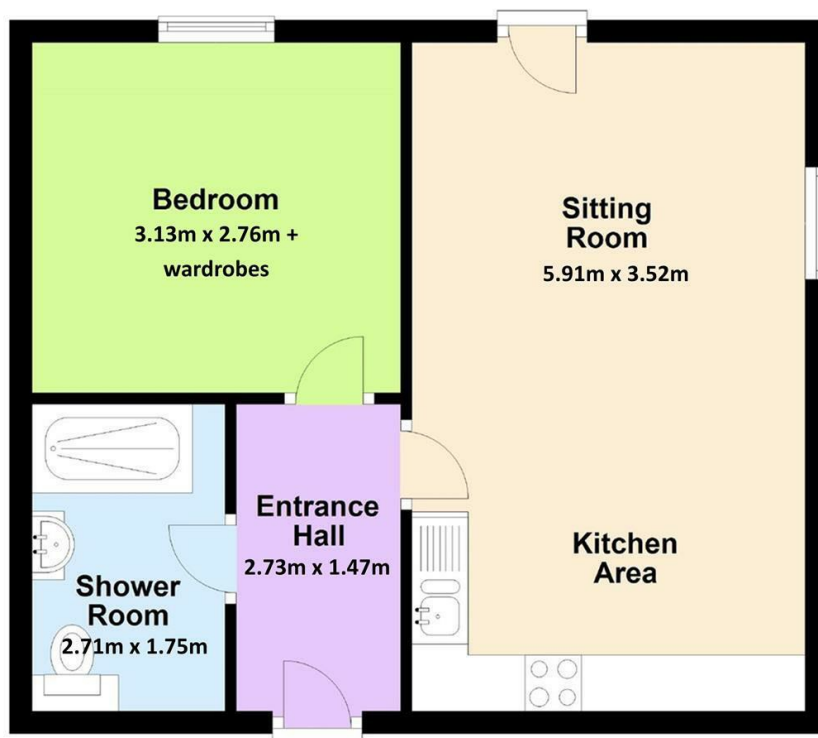

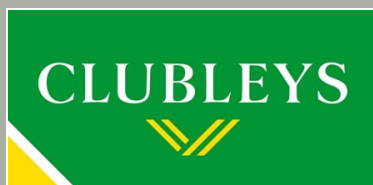
